I/we agreenot to sue any Releasees, and I/we release and agree to assign, heirs and next of kin for any and all loss or damage, and any claims or demands thereafter on account of injury to the person or property or death of undersigned whether caused by the negligence of the Releasees or otherwise. I/we agree that the release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State where these activities are conducted, and ifany part thereof is held invalid, it is agreed that the balance shall continue in full effect.
